

OFFICIAL CALL
Mass Meeting of the Prince George County Republican Committee (PGCRC)
of the Republican Party of Virginia

As Chairman of the PGCRC of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Wayne Cunningham, do hereby issue this call for a Mass Meeting to be held at Human Services, Bldg. #12, 6450 Administration Drive, 1st Floor, Prince George, VA 23875. Registration starts at 6:00 p.m. local time and the meeting starts at 7:00 p.m. local time on April 9, 2018 for the purpose of:

- A. Electing a Unit Chair for the Prince George County Republican Committee.
A mandatory filing fee of \$30 is required and payable to PGCRC.
- B. Electing the members of the Prince George County Republican Committee.

Qualifications for Participation

All legal and qualified voters of Prince George County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Voters may be required to produce personal identification such as a valid driver's license or voter registration card. Attendance is required.

Filing Requirements

- A. Candidates for election as Unit Chairman of the PGCRC shall complete a pre-file form. A mandatory filing fee of \$30 is required and payable to PGCRC.
- B. Candidates for election as Committee Members shall complete a pre-file Membership Form and their annual dues (\$25-Individual, \$30-Couple, \$10-Fulltime Student) payable to PGCRC.
- C. The information and fees required in the above paragraphs shall be received by PGCRC Treasurer, Barbara Tabb, at 10457 Jordan Parkway, North Prince George, VA 23860, by 5:00 P.M. on March 30, 2018. Postmark does not govern.
- D. No refunds given on money / fees given with submitted pre-file. Any money / fees not applied as requested will be deemed as a donation to PGCRC.

Registration Fee

There is a voluntary registration fee to participate in this mass meeting of \$10.00 to fund the costs of the mass meeting.

Publication of Call

Mass meeting call will be posted online as permitted by RPV Party Plan and distributed by other electronic means. Newspaper publication is waived.

Revisions

In the event that the Call requires technical or conforming changes, the Unit Chair of the PGCRC is authorized to revise the Call to make any such technical changes. The Unit Chair shall promptly notify the Committee Members of any such technical changes.
